



AGREEMENT TO BE INCLUDED IN THE STUDIO SAFARI CIRCUIT & CONSIGNMENT POLICY

This Co	onsignment Agreement, dated is made between
(The "A	Artist/ Gallery") and NIKETA FAZAL (the "Consignee") on who agree to be bound by this Agreement.
	REAS, the Artist owns right and title to the "Artwork", and the Consignee agrees to take responsibility of the
	ned art with the intention of selling it to a third party either during the event or Tour ("Studio Safaris").
1.	RIGHT TO SELL. The Consignor hereby grants to the Consignee the right to display and sell the
	Consigned items according to the terms and conditions of this Agreement
2.	CONSIGNMENT FEE. The Consignor shall allow the Consignee a 15% commission for works sold.
	The Consignee will pay the Consignor the sold price minus the 15% commission and 5% withholding tax
	within 5 working days for artwork sold
3.	INSURANCE. Whereas, the Consignee will endeavour to safeguard the Consigned items, the
	Consignor shall maintain insurance coverage on the Consigned item in the event of damage due to
	fire, theft, or otherwise.
4.	LOCATION OF ITEMS. The Consignee agrees and acknowledges that the Consigned items shall
	only be kept and stored at their home office (Runda) unless otherwise agreed upon by the Consignor
5.	TIME FRAME. In the event that all Consigned items are not sold within 1 months from date of
	delivery all unsold Consigned items shall be returned to the Consignor with all delivery costs borne
	by the Consignor.
6.	CONSIGNOR REPRESENTATION. The Consignor hereby, represents and warrants that the works
	will be appropriately shared within the collector database and the Consignee studio will also be added
	to the Studio safari tours, to ensure exposure.
As an A	Art Curator and event organiser we aim to ensure seamless operations of the events and tours by:
1.	Ensuring consistent communication on pricing, discount, and return/exchange policy.
2.	Using your supplied bio and profile to tell your story to engage collectors as your designated trustee.
	Storytelling is KEY -we really want to promote your story so please share it with us!
3.	All artworks must be supplied with your name, medium, title and price.
4.	We will communicate delivery locations for events at least 2 days ahead of events.
5.	Please confirm your participation 24 hours ahead of the planned delivery so we can plan accordingly.
6.	Delivery notes with the Artists signature or representative should accompany artworks.
